Infection Prevention and Safety

State oral health programs have a shared responsibility for the safe delivery of oral health care. ASTDD formulates and promotes the establishment of national dental public health policy, assists state/territorial dental programs in the development and implementation of programs and policies for the prevention of oral diseases; builds awareness, and strengthens dental public health professionals' knowledge and skills by developing position papers and policy statements; provides information on oral health to health officials and policymakers, and conducts conferences for the dental public health community.
